remove defect (s), as pointed out by the office, if any, within a  
  
period of four weeks on resumption of physical mode.

Heard learned counsel for the petitioner and learned  
  
APP for the State.

The petitioner has preferred this application for grant  
  
of regular bail in a case registered u/s 341, 323, 324, 307, 302,  
  
120B and 504 read with 34 of the Indian Penal Code and 27 of  
  
the Arms Act.

As per the prosecution case, the informant has alleged  
  
that the petitioner and co-accused persons started abusing and  
  
assaulting the informant's son Yasir Arafat and his friend Rehan



who took tea with Aashish, Abdullah, Sonam, Smith, Utkarsh and reached near Remhro restaurant. In the mean time, co-accused Golu Singh and Pritam Thakur started firing from their pistols which hit near the chest of the informant's son Arafat and the neck of Rehan causing severe injuries to them. The informant's son Arafat fell down and died on the spot. The injured Rehan was taken to the hospital for treatment.

Learned counsel for the petitioner has submitted that the petitioner is innocent and has falsely been implicated in this case. The petitioner has clean antecedent as stated in para 3 of the bail petition. The name of the petitioner has sprung up in the confessional statement of Harsh Raj. As per F.I.R., the specific allegation of firing is against the co-accused Pritam Thakur and Golu Singh. The other co-accused person has already been granted bail vide order dated 24.08.2022 passed in Criminal Misc. No. 27731 of 2022 by this Court. The petitioner is in custody since 11.01.2022.

Learned A.P.P. for the State has vehemently opposed the bail petition of the petitioner.

Considering the aforesaid facts and circumstances of this case, the petitioner is directed to be enlarged on bail on furnishing bail-bond of Rs.20,000/- (Rupees Twenty Thousand)



with two sureties of the like amount each to the satisfaction of  
learned Additional Chief Judicial Magistrate, East Muzaffarpur ,  
in connection with Kazi Mohammadpur P.S. Case No. 11 of  
2022.

The application stands allowed.
