1. That this is an application for issuance of writ(s), order (s) and direction (s) by directing the Respondent authority to make payment of maturity amount of Rs. 1,06,635/= (One lakh six thousands six



hundered thirty five) on investment of Rs. 50000/= (fifty thousands) with compound interest @ 18% per annum to the petitioner since the date of its maturity which has been taken by them at once on 21.12.2012 under 72 month scheme/ plan launched by them after issuing receiving receipt by the Respondent No.5.
