2 13-07-2022 The petitioner has prayed for the following relief/s :-

- (i) For issuance of a writ in the nature of mandamus
directing the Respondents to comply as per
Category – Wise Merit – Based Reservation
Roaster for Interview (Subject- Hindi) which
says that the total candidates to be called for



interview: $27 \times 3 = 81$ i.e. for one seat three candidates to be called for interview.

- (ii) To issue an appropriate writ in the nature of mandamus to set aside the list of candidates called for Interview (Subject- Hindi) under WBC category as the candidates are filled the form under BC category and also the roster was ignored to selecting the candidates for interview.
- (iii) To issue an appropriate writ(s)/direction(s) for enquiry that candidates of whose selection is being made competition less by selecting just two candidates under such category which shows the irregularity in selection process as Dr Punam Kumari is a wife of Dr. Rajendra Sah, HOD of Hindi Department LNMU, Darbhanga.
- (iv) To issue an appropriate writ(s)/direction(s)/order(s) for stay the procedure of selection of the Guest/Part time teacher vide advertisement no. **PTT-01/2021** till the pendency of this writ application.
- (v) To issue an appropriate writ(s)/direction(s)/order(s) including a writ in nature of mandamus thereby directing the Respondents to take action in facts and circumstances of the present case.



Learned counsel for the petitioner seeks permission to withdraw the present petition as it has become infructuous.

Permission granted.

Present petition stands disposed of as withdrawn having become infructuous.

Interlocutory application, if any, also stands disposed of.
