benefits, however it is the claim of the petitioner that some more



amount is required to be paid, for which the petitioner is ready and willing to approach the contemnors by filing appropriate representation.

The learned counsel for the contemnors Ms. Shilpa Singh (GA 12) submits that according to the contemnors, the order of this Court dated 21.02.2019 has stood complied with in totality.

Accordingly, the present petition stands disposed off, however with liberty to the petitioner to seek redressal of his subsisting grievances before the concerned State Authorities.
