Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- i) For issuance of direction upon the respondent authorities to settled the account of the petitioner after adjusting the payments already made by him and to reschedule the loan account by fixing different installments for left over money so that petitioner may regularize his C.C.A. account with the respondent bank.



- ii) For further direction upon the respondent Bank not to take any action / coercive action against the petitioner in terms of the provisions of SARFAESI Act, 2002 during pendency of this writ application.
- iii) For any other relief or reliefs for which the petitioner is found entitled in the facts and circumstances of the case.

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition reserving liberty to take recourse to such other remedies, as are otherwise available, in accordance with law.

Permission granted.

We are sure that as and when any such proceedings are initiated, before the appropriate forum/Tribunal, the same shall be considered and decided expeditiously, in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

It is made clear that we have not expressed any



opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with
the liberty aforesaid.

Interlocutory application(s), if any, shall stand
disposed of.
