Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

1. That this writ application is being filed for issuance of an appropriate writ /writs direction/ directions commanding the Respondents authorities to pay the admitted dues of total Rs. 732722/- with interest at Market rate on account of Performance of certain work as per work order of District



Magistrate Dated 9-10-2019 i.e was to supply light arrangement with generation videography, stick Photography in the Simariya Mela Begusarai for the convenience of people.

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition reserving liberty to take recourse to such other remedies, as are otherwise available, in accordance with law.

Permission granted.

We are sure that as and when any such proceedings are initiated, before the appropriate forum, the same shall be considered and decided expeditiously, in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

It is made clear that we have not expressed any opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with the liberty aforesaid.
