To issue an appropriate writ in the nature of mandamus commanding th To the respondents to appoint the petitioner as Aanganwari Se-vika, for Aanganwari Kendra 193 under ward no.7 of Tadhwanandpur Pan-chayat, Block Bairiyya, West Cham-paran as she tops the merit list and sat- isfying the other eligibility criteria.

(C.) Pass any other relief as this Hon'ble Court may deem fit and proper in the interest of Justice.”

In support of the aforesaid relief petitioner submitted representation dated 21.03.2021 (Annexure-4). The concerned respondent has not taken any decision on the petitioner's representa-
tion.

Therefore, the concerned respondent is hereby directed to decide the petitioner's representation dated 21.03.2021 (Anneuxre-4) and proceed to pass speaking order and communi-
cate the same to the petitioner within a period of three months from the date of receipt of this order.
