ORAL ORDER

2 20-07-2022 The present writ petition has been filed seeking the following reliefs:-

“i) For issuance of an appropriate writ in the nature



of mandamus for commanding and directing the respondent authorities concerned to remove the encroachment from the land appertaining to Khata No. 132, Survey No. 103, Area 03 Katha, 10 Dhurs situated in village-sisahani, P.S.+ Block-Zeeradei, District-Siwan, which is Gairmajarua land, which has been illegally encroached by the respondent no. 8 to 14.

ii). For issuance of an appropriate writ in the nature of mandamus for commanding and directing the respondent authorities concerned to dispose off the representation filed by the petitioner with reasoned and speaking order, but the same is still pending.”

At the outset, the learned counsel for the petitioner seeks liberty to approach the Circle Officer, Zeeradei, District-Siwan for redressal of his aforesaid grievances.

Liberty so sought is granted.

The writ petition stands disposed off.
