Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

1. That the present petition is being filed in the nature of mandamus for issuing for direction to Respondents authority to pay admitted balance amount with interest of Rs. 1,23,18,269.91 . In the light of Hon'ble High Court order dt. 15.5.18 passed in C.W.J.C. No.18588 of 2016 and further prays for any other relief/reliefs for which the petitioner is entitled for.



After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition reserving liberty to take recourse to such other remedies, as are otherwise available, in accordance with law.

Permission granted.

We are sure that as and when any such proceedings are initiated, before the appropriate forum/Tribunal, the same shall be considered and decided expeditiously, in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

It is made clear that we have not expressed any opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with the liberty aforesaid.
