That the present writ application is being filed on behalf of the sole petitioner for quashing of the proceeding of District Transport Committee, Purnea held on 02.11.2018, as far as it relates to the petitioner, by which the objection filed on behalf of the petitioner against rejection of the technical bid of the petitioner by the District Transport Committee, Purnea, in connection with a tender notice bearing NIT No. 1206 dated 21.07.2018, issued by Bihar State Food & Civil Supplies Corporation Ltd., Khagaria, (Herein after to be referred as corporation) has been rejected.
