Vishunpur Khetal Masjit Tak as per notice No.



(RWD/ Muzaffarpur East-2/ MMGSY (SC)/ Re-Tender/04/2020-21 at Serial No.1 published in Daily Hindustan Newspaper Muzaffarpur dt. 11.05.2020 issued under the signature of Respondent No.-4 Executive Engineer, RWD(W) Division, Muzaffarpur East-2.

It is further prayed that during the pendency of the writ petition to stay the operation of the aforesaid notice with regard to serial no. 1 till the including of water channel (pullia) three Home pipe in road from Bathana Chauk to Vishunpur Khetal Masjid Tak in the light of aforesaid tender. As per tender notice road is not estimated as serial no.1 including the water channel in said road Batha Chauk to Vishunpur Khetal Masjid Tak.”

After some argument, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Additional Chief Secretary, Rural Work Division, Government of Bihar, Patna i.e. the Respondent No. 5 for agitating his aforesaid grievances. Liberty so sought is granted.
