ORAL ORDER

2 25-02-2022 Heard the parties.

The petitioners apprehend their arrest in connection with Buxar (Muffasil) P.S. Case No. 173 of 2021 registered for the offence under Sections 147, 149, 341, 323, 379, 506 of the Indian Penal Code and 27 of the Arms Act.



Learned counsel for the petitioners submits that seven other co-accused, who have also been named in the F.I.R., granted anticipatory bail by this Court. All the injuries are simple in nature.

Taking into consideration above and case of the petitioners being identical to the others, who have been granted anticipatory bail, I am inclined to grant benefit of anticipatory bail to the above named petitioners and in the event of arrest they shall be released on bail, subject to the conditions as laid down under Section 438 (2) of the Cr.P.C. as well as the following conditions:-

1. The above named petitioners, furnish personal bond with their recent self-attested photograph and surety of the like amount on the following conditions at the satisfaction of the investigating officer.
2. The petitioners shall cooperate with the investigation and make themselves available for interrogation whenever required.
3. The petitioners shall not directly or indirectly make any inducement, threat or promise to any witness acquainted with the facts of the case so as to dissuade them from disclosing such facts to the court or to any police officer,



4. The petitioners shall not obstruct or hamper the police investigation and not to play mischief with the evidence collected or yet to be collected by the police;

5. The petitioners shall not leave the territory of Buxar (District name) without prior permission of the court, till trial is over;

6. The petitioners shall maintain law and order;

7. The petitioners shall, at the time of execution of the bond, furnish their address and mobile number to the investigating officer, and the court concerned, and shall not change the residence till the final disposal of the case;

8. The petitioners shall surrender their passport, if any, before the investigating officer within a week and, if they does not possess any passport, they shall file an affidavit to that effect before the investigating officer;

9. The petitioners shall regularly remain present during the trial and cooperate with the Hon'ble court to complete the trial for the above offences.
