Learned counsel for the petitioners is permitted to

The petitioners apprehend their arrest in connection
with Sahajitpur P.S. Case No. 68 of 2021 registered for offences
under Sections 448, 504, 323, 354-B, 379 and 376/34 of the
Indian Penal Code.

Learned counsel for the petitioners seeks
permission to withdraw this bail application on behalf of



petitioner nos. 3, 4 and 5, above named, as they have been arrested.

Accordingly, this bail application is dismissed as withdrawn as against petitioner nos. 3, 4 and 5, above named.

So far as the bail of petitioner nos. 1 and 2 is concerned, the same is allowed considering the delay in lodging the F.I.R and also the fact that no offence under S.C./S.T. Act is made out against them.

Accordingly, let petitioner nos. 1 and 2, above-named, in the event of their arrest or surrender within four weeks from today, be released on bail on furnishing bail bond of Rs.10,000/- (Rupees ten thousand) each with two sureties of the like amount each to the satisfaction of learned 1st Additional District & Sessions Judge-cum-Special Judge, S.C./S.T. (POA) Act, Saran at Chapra, in connection with Sahajitpur P.S. Case No. 68 of 2021, subject to the conditions as laid down under Section 438(2) of the Cr.P.C.
