2 02-12-2022 Petitioner has prayed for the following relief(s):-



- (i) For setting aside the order dated 26.2.2019 passed by Ld.Sr.Divisional Commercial Manager, East Central Railway Danapur with respect to representation dt. 15.1.2019 made by the petitioner whereby and whereunder the prayer of the petitioner for reopening of JTBS/ Madari Musafir Khana, Patna Junction has been dismissed/ rejected.
- (ii) For setting aside the order dated 10.8.2017 passed by DRM/DNR Sri Ramesh Kumar Jha whereby and whereunder Ld D.R/DNR was pleased to reject the prayer of the petitioner to allow to reopen/restart JTBS namely Madari Musafir Khana at Patna Junction.
- (iii) For setting aside the termination order dated 3.3.2016 passed by Ld Sr.DCM, EC Railway Danapur whereby and whereunder he was pleased to terminate the licence/order of permission given to the petitioner to run JTBS in name of Madari Musafir Khana at Patna Junction authority concerned .
- (iv) To allow/grant permission to the petitioner to restart /reopen counter no. 36 JTBS, Madani Musafir khana Patna junction.
- (v) For any other relief for which the petitioner is entitled in the facts and circumstances of this case.



Learned counsel for the petitioner seeks permission to withdraw the present petition in view of the order dated 29.11.2018, passed by a learned Single Judge of this Court in CWJC No. 14529 of 2017, titled as Anwar Siddique Vs. The Union of India & Ors. (Annexure-10, Page- 48), which is extracted as under:-

“In view of the arbitration clause bearing Clause-11 of the agreement entered into between the parties, the petitioner seeks liberty to invoke the arbitration clause.

Accordingly, the present writ petition is disposed of with the aforesaid liberty.”

The instant petition stands disposed of as withdrawn.
