ORAL ORDER

(Per: HONOURABLE THE CHIEF JUSTICE)

2 18-08-2022 Petitioner has prayed for the following relief(s):-

- (i) To pay dues of the petitioner amounting to Rs.5,04,000/- which is subsidy amount to be borne by the State of Bihar in the Agriculture Department in respect to supply of 168 numbers of Chaff Cutter (Manual) machines to 168 numbers of small farmers of different villages in Jehanabad District under Government Scheme to provide Chaff Cutter machines on subsidised rate to small farmers. The total cost of machine was Rs.6500/- out of which Rs.3500/- was to be



paid by the Government to supplier of the Chaff Cutter machine. The amount of Rs.5,04,000/- have not been paid to the petitioner for the reason that no fund has been provided by the Department to District Agriculture Officer, Jehanabad (Respondent No.6):

- (ii) To pay interest on the total dues amount of Rs.5,04,000/- at the rate of 9% per annum from the date of supply in December 2015 till the date of payment;
- (iii) To pass any other order or orders as deem fit and proper in the facts and circumstances of this case.

Learned counsel for the petitioner seeks permission to withdraw the present petition, for the grievance of the petitioner already stands redressed.

Permission granted.

The instant petition stands disposed of as withdrawn.

Interlocutory Application(s), if any, shall stand disposed of.
