2 25-08-2022 Petitioner has prayed for following reliefs:-

“I. For setting aside the joint order dated 27.07.2022 contained in Memo No. 1198 issued under the signature of Respondent District Magistrate and Superintendent of Police, Saran, Chapra whereby and whereunder they have appointed Magistrate and police force for taking possession of the



property in question by fixing date on 12.08.2022.

II. For direction to the respondent not to dispossess the petitioner from his property in question pursuant to the impugned order dated 27.07.2022 till the disposal of SARFAESI Appeal No. 201 of 2021 pending before the Debt Recovery Tribunal, Patna.
