2 14-12-2022 Heard learned counsel appearing on behalf of the
petitioner, learned APP appearing on behalf of the State and
learned counsel appearing on behalf of the informant.

Let the defect(s), if any, be removed within a period
of four weeks from today.

The petitioner seeks bail in connection with Turkaulia
P.S. Case No. 669 of 2021 registered for the offence under
Sections 341, 323, 302, 326 and 34 of the Indian Penal Code.

The accused/petitioner is named in the F.I.R. and is in



custody since 27.06.2021.

The allegation against the petitioner is to commit murder of husband of the informant, alongwith other co-accused persons, by assaulting with knife, due to previous enmity arises out of local disputes and differences.

Learned counsel appearing on behalf of the petitioner submitted that allegation, as appears maximum against this petitioner, as per the face of F.I.R., is only of order giver, whereas specific allegation to give fatal assault is available against co-accused, namely, Mansoor Ansari. While concluding the argument, it is submitted that petitioner is a man of clean antecedent and, moreover, investigation in this case is complete for which chargesheet has been submitted, as such, there is no chance of tampering with the evidence.

Learned APP, duly assisted by learned counsel appearing on behalf of the informant, opposes the prayer of bail.

In view of the facts and circumstances, as mentioned above, as allegation against this petitioner is only of order giver, as per the face of the F.I.R. coupled with the fact that chargesheet has been submitted, let the petitioner, above named, is directed to be released on bail in connection with Turkaulia P.S. Case No. 669 of 2021 on furnishing bail bond of



Rs.10,000/- (Rupees Ten Thousand) with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, East Champaran, Motihari/concerned Court, subject to the conditions as laid down u/s 437(3) of the Cr.P.C.
