Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- (i) For commanding the respondents to remove electrical high tension wire passing over the land and house of the petitioner and compensate for the same.
- (ii) For providing security to the life property of the petitioner and her family members.
- (iii) For any other appropriate relief/reliefs to which the petitioner is found entitle in the facts and circumstances of this case including the cost of litigation and mental agony.

Learned counsel for the respondents, states that similar petition being **C.W.J.C. No. 10609 of 2020**, titled as **Sushma Kumari @ Sushma Devi Vs. The Managing Director, South Bihar Power Distribution Co. Ltd.**, was disposed of by a co-ordinate bench of this Court vide judgment dated 17.01.2022, and the present petition may also be disposed of in the light of the said petition.
