Petitioner has prayed for following relief:-

- a. To quash/set-aside the order issued vide
memo no. 1965 Baisi dated 22.07.2021 whereby
and where under the respondent no.4 (S.D.O.
Baisi) pleased to cancel the license no.26
of 2018 of the petitioner on whimsical and
arbitrary manner.
- b. To restore the license of petitioner on
immediate effect because customer of the
shop feel difficulties in getting foods.

c. Any other relief(s) for which petitioner entitled under the law may be given to her.

Petitioner has approached this Court without exhausting the statutory remedy of appeal against the impugned order, as such, petitioner is granted liberty to file an appeal before the appellate authority against the order passed by the Sub Divisional Officer, Baisi, Purnea -cum- licensing authority, and if any such appeal is filed within 4 weeks from today, the appellate authority shall condone the delay in filing the appeal and shall decide the appeal on its own merit preferably within 8 weeks from the date of its filing.

With aforesaid liberty, the writ petition stands disposed of.
