Heard learned counsel for the petitioner and the State.

The petitioner prays for grant of anticipatory bail in Dulhin Bazar P.S. Case No. 129/2021 registered for the offence punishable under Section 307 and other allied sections of the Indian Penal Code.

There is specific allegation of assault against the petitioner causing injury on the neck.

In view of the above, this is not a fit case for grant of anticipatory bail. It is, accordingly, dismissed.

The specific allegation of assault is against Sunil Kumar.

Considering the facts and circumstances of the case,



the present anticipatory bail application is allowed.

Accordingly, let the petitioners above named be released on bail, in the event of their arrest or surrender before the court below within a period of four weeks from today, on furnishing bail bonds of Rs.10,000/- (Ten Thousand) each with two sureties of the like amount each to the satisfaction of learned J.M. 1st Class, Danapur, Patna, in connection with Dulhin Bazar P.S. Case No. 129 of 2021, subject to the conditions as laid down under Section 438 (2) of the Cr.P.C.
