- 2 25-08-2022 Petitioners have prayed for the following relief(s):-
- i. To direct the respondent authorities to make the payment to the petitioners of the award amount of



Rs. 12,32,725/- and earnest money of Rs. 50,000/- as well as security deposit deducted from the bill of the petitioner in terms of the order dated 25.05.2017 passed by Arbitration Tribunal (Annexure-2) along with 18 % interest over the dues amount till realization of the money.

- ii. To direct and command the respondents to pay with 12 % interest from the date of dues i.e. 21.03.2006 the date on which a certificate of completion of work was issued by the Dy. Chief Engineer / Con III, E C Railway, Patna to the date of actual payment for the execution of work under agreement referred below between respondents and the petitioner.
- iii. To initiate a contempt proceeding against the respondents for inaction / wrong action of the on their part for intentionally and willfully delaying the matter and unnecessarily harassing the petitioner.
- iv. To grant permission to add, amend, modify or otherwise vary the grounds in support of this writ.
- v. To grant any other relief or reliefs to which the petitioner is otherwise found entitled to along with the cost of the litigation throughout.

Learned counsel for the petitioner seeks permission to withdraw the present petition reserving liberty to take recourse to appropriate remedy in accordance with law.

Permission granted with liberty as prayed for.

The instant petition stands disposed of as withdrawn.
