2 08-12-2022 Petitioner has prayed for the following relief(s):-



- I. That the present writ application is being filed in the nature of *Certiorari* for quashing the tender notice dated 06.02.2019 issued by the Managing Director, B.S.F.C, by which notice has been invited for e-tendering for selection and empanelment of main and door step delivery transporter, contractor in the District of Vaishali; on the ground that the petitioner's are already working as door step delivery agent in the District of Vaishali and their agreement for three years i.e. for 2018 till 2021, there is no extra work beyond the work allotted to the transporter already working;
- II. That the present writ application is being filed in the nature of *Mandamus* for a direction to the District Transport Committee, B.S.F.C, Vaishali as well as the District Manager, B.S.F.C, Vaishali to continue the agreement of Transporter-cum-Handling Agent of the petitioner as door step delivery without redistributing the work in the light of Annexure No.2 and 2/A (agreement) and further allow to work as the Transporter cum Handling Agent in the District of Vaishali;
- III. For issuances of an appropriate writ/order or directions for which the petitioner is entitled for.

Learned counsel for the petitioners seeks permission



to withdraw the present petition, for the same having rendered
infructuous.
