from today.

Heard learned counsel for the petitioner and learned
A.P.P. for the State.

It is a case which has been rejected earlier vide order
dated 27.01.2021, passed in Cr. Misc. No. 34251 of 2020.

Progress report has been called twice in this case. It
has been intimated by the latest progress report of the trial that
next common statement under Section 313 of the Cr.P.C. dated
11.05.2022. Let the bail is hereby rejected directing the Trial
Court to conclude the trial within 3 months from today.

Speedy trial is the constitutional vision of justice.
Admittedly, there are in total 25 criminal cases (including the
present one) pending against the petitioner which belongs to the
