2      05-07-2022                      Heard learned counsel for the petitioners and learned counsel for the State.

The petitioners apprehend their arrest in Wazirganj P.S. Case No. 154 of 2021, registered for the offences punishable under Sections 308, 379 and other allied sections of the Indian Penal Code.

Prosecution case in brief is that all the accused persons forcibly entered into the house of informant looted ornaments. When informant raised alarm, petitioner no. 1 Aditya



Paswan assaulted the informant on his head by iron rod and other accused persons assaulted informant's family members.

It is submitted that both parties are co-villagers and due to petty dispute an altercation took place in which both sides sustained injuries. Case and counter case. Present case is counter blast of Wazirganj PS Case No. 155 of 2021. Injury caused by petitioner's side is simple in nature. Petitioners have got clean antecedents.

Considering the facts aforesaid, the petitioners above-named, in the event of their arrest/surrender before the court below within a period of six weeks from the date of receipt/production of a copy of this order, are directed to be enlarged on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) each with two sureties of the like amount each to the satisfaction of the learned Additional Chief Judicial Magistrate Ist, Gaya in connection with Wazirganj P.S. Case No. 154 of 2021, subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure.
