“A. A writ in the nature of certiorari or any other appropriate writ, order/s quashing:

(i) Order dated 13.08.2022 vide Letter No.DHS/BXR/524 issued pursuant to the bid invited vide Tender Notice Ref No.:DHS/NCS/CLN/2018-308 dated 23.06.2022 whereby M/s Neelam Printers & General Order Suppliers (R-6) has been awarded tender.

B. Grant such other reliefs as this Court deems fit in the facts and circumstances of the case.”

Learned counsel for the petitioner states that his client is aware of the contract being executed subject to the



outcome of the present petition.

Mr. Vikash Kumar, learned SC-11 states that from the reading of the petition, it is evidently clear that there are no averments, much less, the allegations pleaded against respondent No.6, namely, Evanta Global Pvt Ltd, 1-5 Fifth Floor, Exhibition Road, Patna- 800001, Bihar.
