6 02-08-2022 The petitioners have prayed for the following relief/s :-

- (i) An appropriate writ/order/direction declaring the provisions of section 14A(1) being repugnant to section 13A(1) and Article 19(1)(c) read with Article



243-ZI of the Constitution, in so far as Primary Agriculture Credit Cooperative Society like the petitioner no.1 as illegal, ultra vires and unconstitutional be issued;

- (ii) On grant of relief no.1, an appropriate writ/order/direction declaring the provisions of Bihar Election Authority Act as not applicable in so far as Agriculture Cooperative Society functioning in the State of Bihar be issued;
- (iii) An appropriate writ/order/direction quashing the notices issued by the respondent Election Authority, as contained in Annexure-2 series, as illegal, arbitrary and without jurisdiction be issued;
- (iv) An appropriate writ/order/direction commanding the respondents to forbear from interfering in any way with the functioning of the petitioner no.1 society including the constitution of managing committee, etc. be issued;
- (v) Any other relief or reliefs to which the petitioners are entitled to be granted.



Learned counsel for the petitioners seeks permission
to withdraw the present petition.
