Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

1. That, the petitioner seeks the following reliefs byway of the Present writ petition:-

- (i) For issuance of an appropriate Writ/writs, order/ orders, direction /directions in the nature of Mandamus especially ^{upon} ~~to~~ the respondent no. 2 to make an ^{insuring} ~~Consuming~~ / inspection ^{from} ~~his~~ own leveled against the respondent no. 5 to 11 who have knowingly misbehave with the local People / Shop keeper in their locality/ area, demanded illegal gratification from them and not fulfillment their demand, they have implicated the people / shopkeeper in the false case of theft of Electricity and thereafter take a Suitable action against the respondent no. 5 to 11 after making inspection from own level

(ii) To direct the respondents to unless and until ^{inquiry} ~~insuring~~ has not been completed against the respondent no. 5 to 11 as allegation leveled against them, a fine of Rs. 67917/- which has been imposed against the petitioner may kindly be set aside or kept in abeyance.

(iii) To direct the respondents to not take any coercive action against the petitioner during Pendency of the writ petition.

(iv) To grant any other relief/reliefs to the petitioner under the facts and circumstances of the case as well as in law.

Learned counsel for the petitioner seeks permission to withdraw this petition.

Permission is granted.

This petition is disposed of as withdrawn.
