2 23-02-2022 Heard learned counsel for the petitioner and the State.

Learned counsel for the petitioner is directed to remove the defect(s), as pointed out by the office, within a period of eight weeks.

The present application has been filed for modification of the order dated 05-03-2020 passed by a coordinate bench (then His Lordship was) in Cr. Misc. No. 57538 of 2019 by which the petitioner was granted anticipatory bail in connection with Sitamarhi (Mahila) P.S. Case No. 21 of 2016 pending in the court of learned Sub Divisional Judicial Magistrate, Sadar, Sitamarhi.



It is submitted on behalf of the petitioner that due to Covid-19 pandemic, the petitioner could not surrender within the stipulated time. It is further prayed on behalf of the counsel for the petitioner that further time may be extended so that the petitioner could surrender in the court below.

Considering the submissions made on behalf of the learned counsel for the petitioner and the grounds mentioned in the modification application, the period of surrender of the petitioner in the court below is extended for a further period of eight weeks from the date of receipt/production of a copy of this order. The rest of the conditions shall remain the same as mentioned in the order dated 05-03-2020 passed by a coordinate bench (then His Lordship was) in Cr. Misc. No. 57538 of 2019.

The order dated 05-03-2020 passed by a coordinate bench (then His Lordship was) in Cr. Misc. No. 57538 of 2019 is modified to the extent as indicated above.

The modification application is, accordingly, disposed of.
