Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

1 That this is an application for issuance of a writ in the nature of Mandamus or any appropriate writ's, order's, direction's commanding the Respondents for following reliefs-

i For direction the respondents to make payment of Rs 311,710 / as last instalment with statutory interest against the work where by wife of the petitioner late Vijay Lakshmi kumari as in-charge Headmaster of Middle school ,Ben ,Nalanda constructed 2 ACR school's building in the year 2006-07,2 ACR building in 2009-10 again 3 ACR building in 2009-10 and 2 ACR building in 2010-11 .

ii For other order or direction in the facts and circumstances of the case in the interest of justice .

After the matter was heard for some time, finding the Court not in favour of the submissions made by the learned counsel for the petitioner, learned counsel for the petitioner, under instructions, states that the petitioner will be content if the petitioner is permitted to withdraw the present petition, with liberty to initiate appropriate proceedings before the appropriate forum and to take recourse to such other alternate remedies which are equally efficacious in law.
