Heard learned counsel for the petitioners and the State through video conferencing.

The petitioners pray for grant of anticipatory bail in Bela P.S. Case No. 47 of 2020 registered for the offence punishable under Sections 341, 323, 324, 307, 504/34 of the Indian Penal Code.

In view of general and omnibus allegations levelled against the petitioners, the present anticipatory bail application is allowed.

Accordingly, let the petitioners No. 3,4, 5, 6 and 7 above named be released on bail, in the event of their arrest or surrender before the court below within a period of ten weeks from today, on furnishing bail bonds of Rs.10,000/- (Ten Thousand) each with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, Sitamarhi, in connection with Bela P.S. Case No. 47 of 2020 subject to the conditions as laid down under Section 438 (2) of the Cr.P.C.
