2 20-07-2022 The present writ petition has been filed seeking the
following reliefs:-

*“(i) For issuance of an appropriate writ/writs,
direction/directions in the nature of mandamus
directing the respondent no. 4/Circle Officer,
Daraunda, District-Siwan to initiate the
encroachment proceedings against the private*



respondents/Encroachers and decide the encroachment case to its logical conclusion within short span of time by removing the encroachment made by the encroachers/private respondents over the Khata No. 637, Survey No. 3613, Thana No. 563, ara 2 Bigha, 3 Katha, 11 Dhur, situated in village-Pakwaliya, Block-Daraunda, District-Siwan, which is State Government land.”

At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Daraunda, District-Siwan for redressal of his aforesaid grievances under the provisions of the Bihar Public Land Encroachment Act, 1956.

Liberty so sought is granted.

The writ petition stands disposed off.
