2      01-12-2022                      Though the present writ petition was filed for directing the respondents to register the sale deed in question, with respect to Plot no. 249, Khata no. 300 in Mauza Sabaur, PS-Sabaur, Thana no. 27, Halka no. 02, Dist-Bhagalpur and 21.30 decimal of land in Plot no. 242, Khata no. 247 in Mauza Sabaur, PS-Sabaur, Thana no. 27, Halka no. 02, Dist-Bhagalpur, however, the learned counsel for the respondent State has filed a



counter affidavit, wherein it has been stated that as far as the aforesaid land in question is concerned, the sale deed pertaining to one portion, which was presented for registration has already been registered and as far as the other portion is concerned, the same has not been attached by the Enforcement Department.
