Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

(A) A writ in the nature of Certiorari or any other appropriate

writ/s, order/s direction/s quashing the following:

(i) The Letter No. 1396 dated 24.09.2021 issued under
the signature of Respondent No. 2 by way of which



the Respondent No. 2 has ordered to make payment to the Petitioner after deducting 20% from Rs.27,00,000/- (Rupees Twenty Seven Lakhs Only).

(ii) Show-cause issued by the Respondent No. 3 vide Memo No. 805 dated 15.07.2021

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, states that petitioner shall be content if the petitioner is permitted to withdraw the present petition reserving liberty to initiate appropriate proceedings before the appropriate forum and/or take recourse to such other alternative remedies, equally efficacious in law.

Permission granted.

We are sure that as and when any such proceedings are initiated, the same shall be considered and decided in accordance with law.

Needless to add, the authorities/adjudicative body



shall pass a reasoned order in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

It is made clear that we have not expressed any opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with the liberty aforesaid.

Interlocutory Application(s), if any, shall stand disposed of.
