“To issue appropriate rule/rules, direction/directions, writ/writs for directing the respondent authorities particularly Respondent Nos. 4 to 13 to make payment of dues amount of Rs.30,00,000/- to the petitioner for the work done under the ambitious scheme of Nal Jal Yojana in Ward Nos. 5, 6 & 7 of Gram Panchayat Shankarpur, Block – Shivaji Nagar, Samastipur and for any other relief or reliefs for which the petitioner be found entitled in law be granted to him.”

Shri Nirbhay Prashant, learned counsel for the petitioner, under instructions, fairly states that on account of intervening developments, the present petition be disposed of inasmuch as now the petitioner has taken recourse to the alternate remedies stipulated under the agreement as also law applicable, governing the parties to the lis.

Accordingly, petition is disposed of with the liberty to



the petitioner to pursue the remedies in accordance with law.
