ORAL ORDER

4 24-11-2022 Heard learned counsel for the parties.

The parties are in agreement that the dispute can be resolved by a direction to the concerned Court for disposing the Title Suit pending between them at the earliest.

In these circumstances, the Sub-Judge-I, Saran at Chhapra is directed to dispose of the Title Suit No. 625/2019

within a year from the date of communication of the order.

The Sub-Judge-I will proceed in the matter regularly and if any of the parties does not co-operate in the disposal of the Suit then the Court will proceed *ex-parte* against the non-cooperating party.

With the aforesaid observations and directions, this application is disposed of.
