Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

That the present writ application is being filed in the nature of public interest litigation on behalf of the petitioner above named for issuance of the following reliefs:-

- (i) For issuance of an appropriate writ/order/direction in the nature of mandamus directing the respondent authorities to conduct a vigilance enquiry in the entire process of appointment of lecturers of training college through advertisement no. 02/2016 and 06/2016 as early as possible so that the mismanagement of the government money/public money could be stopped and the guilty persons be prosecuted accordingly.
- (ii) For holding that the entire process of appointment of lecturers through advertisement no.02/2016 and 06/2016 stands vitiated due to various kinds of illegalities committed by the respondent

authorities including changing the rules/specifics of the advertisement during the process of selection, with an oblique motive to oust the genuine candidates and to serve the vested interests.

- (iii) For any other relief or reliefs, order/orders which the Hon'ble Court may deem fit and proper in the eye of law and which the petitioner may found to be entitled in the facts and circumstances of the case.

Learned counsel for the petitioner seeks permission to withdraw the present petition.

Permission granted.

The instant petition stands dismissed as withdrawn.
