ORAL ORDER

2 25-02-2022 Heard learned counsel for the petitioner and Mr. Humayou Ahmad Khan, learned A.P.P. for the State through virtual court proceedings.

The petitioner seeks bail in connection with Daudnagar P.S. Case No. 514 of 2021 instituted for the offences under Sections 413 and 414 of the Indian Penal Code read with Sections 30(a), 34 and 36 of the Excise Act and Sections 25(1-b)a, 26 and 35 of the Arms Act.

Learned counsel for the petitioner submits that the petitioner is in custody since 16.09.2021, is a person with clean antecedent and charge-sheet has been submitted in the case.

Learned counsel for the petitioner submits that the allegation is of recovery of a mobile, cheque of Rs. 50,000/- and 86.700 litres of liquor from Bolero along with a loaded country-made pistol from the possession of the petitioner.



Learned counsel for the petitioner submits that the petitioner is the driver of the vehicle and he has been falsely implicated in the case, nothing was recovered from his possession and as far as liquor is concerned, the petitioner being driver was not aware who had kept the liquor in the vehicle. Learned counsel submits that to give a serious colour to the case, the police implicated the petitioner with an allegation that he was carrying a pistol when he is a person with clean antecedent.

Learned A.P.P. for the State opposes the prayer for bail of the petitioner.

Considering the fact that the petitioner is in custody since 16.09.2021, is a person with clean antecedent and charge-sheet has been submitted in the case, let the petitioner above named be released on bail on furnishing bail bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of the like amount each to the satisfaction of learned Additional District and Sessions Judge-II-cum-Special Judge, Excise, Aurangabad in connection with Daudnagar P.S. Case No. 514 of 2021.
