2 08-12-2022 Petitioner has prayed for the following relief(s):-

1. That this is an application is being filed for issuance of an appropriate writ /writs directing the respondent's authorities for removal of High tension electric wire passing through raiyat^{land} of petitioner bearing khata no 265 Khesra no 470 situated in village Samsa. Which was installed without consent of petitioner or to pay adequate compensation to him against the value of his land.

After the matter was heard for some time, finding the
Court not to be in favour of the submissions made across the Bar,



learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition reserving liberty to take recourse to such other remedies, as are otherwise available, in accordance with law.

Permission granted.

We are sure that as and when any such proceedings are initiated, before the appropriate forum/Tribunal, the same shall be considered and decided expeditiously, in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

It is made clear that we have not expressed any opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with the liberty aforesaid.

Interlocutory application(s), if any, shall stand disposed of.
