2 08-12-2022 Petitioner has prayed for the following relief(s):-

“I. To quash the order contained in Letter vide Ref. LPG.ER.MUZP.BHADAL.2 dated 27-07-2019 issued by Respondent No. 4, by which Registered Lease Deed of the land offered for construction of LPG Showroom for award of LPG Distributorship at location Bhadai, Block-Aurai, District- Muzaffarpur, has been declared invalid on illegal and unjustified grounds, which is also contrary to the norms prescribed in the Brochure for the selection and



award of LPG Distributorship.

II. To direct the Respondent authorities to consider the Registered Lease Deed through which Petitioner has offered land for construction of LPG Showroom, as valid and to issue L.O.I. in favour of the Petitioner pursuant his selection dated 11-01-2019 for award of LPG Distributorship at location Bhadai, Block- Aurai, District- Muzaffarpur, advertised on 17-06-2017.”

Learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition.

Prayer allowed.

Petition is disposed of as withdrawn.
