Petitioner has prayed for the following relief(s):

“(i) For issuance of an appropriate writ/s direction/s, order/s, to the respondents to remove the encroachments from the Old and Natural AHAR-PYNE IRRIGATION SYSTEM / RAIN HARVESTING SYSTEM which is situated in village – Koil Bhupat, Block – Kaler, P.S. - Mehandia, District – Arwal, over the land i.e.

Plot No. 976 958, 1558, 646 & 1476 and Old

731 731 610 990

Plot No. 496 of Khata No. 371 New / 173 Old which is GAIR-MAZARUA – AAM – LAND.

And further restore the same in its original form, which was being used for irrigation as well as for drainage of village waste water.
