“That this is an application for the issuance of Writ in the nature of certiorari or any other Writ/ Writs, Order/ Orders, for the quashing of letter no-3902, dated-31/08/2022, issued by the respondent no-06 (Certificate Officer), whereby and where under a demand notice has been issued under section-7 of the Bihar and Orissa Act No- 4 of 1914 against the petitioner, fixing



the liability of demand Rs. 24,13000/- (Twenty Four Lakhs Thirteen thousand) along with interest, Vide certificate Case No-1292/2022-2023 issued in pen and ink of respondent no-06, for the so called irregularities in implementation of NAL-JaL Yojana of ward no-13 of Village Panchayatiraj Alampur Simri.”

Learned counsel for the petitioner seeks permission to withdraw the present petition reserving liberty to file a fresh petition, on the same and subsequent cause of action, as also pursue the alternative remedies, in accordance with law.
