“That this is an application for direction to the Senior S.P., Rohtas to get seize the Truck No. BR-44G-1051, from he possession of the financier the Rs No-5 to this writ application Registered in the name of petitioner, Partly Financed by the Financier as loan inspite of knowing the order of the Hon'ble Court, passed in the case of Sujay



Kumar Versus UCO Bank reported in BLJ 2020 at page 96, not to seize the vehicle through goons on road though in this case seized through goons on road on 30.09.2021 when sufficient amount was already paid to the finance company against loan advanced.”

Learned counsel for the petitioner, under instructions, fairly states that the petition, in its present form, may be permitted to be withdrawn reserving liberty to file afresh on the same and subsequent cause of action, if so required and desired.

Prayer allowed.

Petition is disposed of as withdrawn with the liberty aforesaid.
