- I. For giving a direction to take appropriate action/enquiry against the erring officials of Arwal District, Arwal Block and Public representatives of Rampur Baina Panchayat (Mukhiya) for embezzlement and defalcation with regard to public fund by way of misappropriation in Mahatma Gandhi National Rural Employment Guaranty Yojna herein after called **MGNREGA**.
- II. For giving a direction to lodged and an F.I.R. though appropriate agency (Department of vigilance) after a full enquiry.
- III. For a direction to proper enquiry of the same by appropriate agency (Department of Vigilance).
