Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- “(a) For quashing the letter no. 1326 (Annexure 5), which is passed by the Executive Engineer, Minor Irrigation Division, Samastipur on dated 23.07.2019.
- (b). For the direction to the respondents to give the



remain payment which work is completed before the dead line as same MB also submitted.

- (c) For issuance of any other Writ/Writs, direction/directions, Order/Orders to which the petitioner is entitled in the ends of justice”.

After the matter was heard for some time, finding the Court not to be in favour of the submissions made across the Bar, learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition reserving liberty to take recourse to such other remedies, as are otherwise available, in accordance with law.

Permission granted.

We are sure that as and when any such proceedings are initiated, before the appropriate forum/Tribunal, the same shall be considered and decided expeditiously, in accordance with law.

Needless to add, period for which the petitioner has been pursuing the matter before this Court, shall be excluded for the purpose of computing limitation.

The petition stands disposed of as withdrawn with the liberty aforesaid.
