2 12-12-2022 Petitioner has prayed for the following relief(s):-

1. That this is an application for issuance of appropriate Writ(S), Order(s), Direction(s) directing the Respondents to connect the electricity immediately in the house of bona fide consumer i.e. petitioner to the electric pole standing in front of house of the petitioner.



Whereby and where under since 2006, the petitioner is valid and bona fide electric consumer to the respondent authorities now North Bihar Power Distribution Company Limited and he has been paying electric rent thereof and there is no dues on petitioner and respondent have changed the electric wire and they laid covered electric wire and they have installed an electric pole which is standing in front of house of petitioner but they have not deliberately connected electric wire to the house of petitioner due to enmity with local contractor and electricians who demanded money instead of supplying the electric in the house of petitioner and due to non fulfilment of gratification as well as discrimination , petitioner has been deprived from electric since 05.09.2019 and he has been deprived from fundamental rights i.e. right to life due illegal action on behalf of the respondents authorities.

And/or

And respondents further be directed to punish guilty respondents for their illegal action for not supplying electric to the house of petitioner causing him deprivation from right to life which is guaranteed in the constitution of India.

And /or

For issuance of any other relief(s) as Your Lordships may deem fit and proper in facts and circumstances of the case.

Learned counsel for the petitioner seeks permission to withdraw the present petition.
