2 09-12-2022 Petitioner has prayed for the following relief(s):-

- i. For a Direction upon the Additional Director General of Police, Economic Offence Unit, Bihar to take over and investigate the Kadam Kuan Police Station, Case No. 383(21 Dt. 12.08.2021 lodged by the Petitioner – Applicant u/s 420,379 IPC herein against the fraudulent and unauthorised debit transactions from his bank account.
- ii. For a Direction upon the State Bank Of India Card and Payment Services Pvt. Ltd, J 498 +QFX Anandpuri, Patna 800013.
- iii. For that entire demand made by respondent 8 is in violation to the Reserve Bank of India notification to Banks in context of Bank forgery
- iv. For that RBI should take note of SBI notice in violation to the specific guidelines vide no DBR.No.Leg.BC.78/09.07.005/2017-18 dated 06/07/2017 issued for reversal of erroneous debits arising out of fraudulent transactions.
- v. For put in place a suitable mechanism and structure for the reporting of the customer liability cases
- vi. For any other relief for which the Petitioner – Applicant herein is found entitled to.

Learned counsel for the petitioner seeks permission to withdraw the present petition reserving liberty to file an appropriate petition on the same and subsequent cause of action.

Permission granted.

The instant petition stands disposed of as withdrawn.
