order or direction commanding/directing the
respondent authorities concerned for not to pass
the proposed 132 K.V.A. electric transmission
line from Mahnar to Goraul through the Tower
No. 35 , over the petitioner’s land bearing
Khata No. 397, Khesara No. 471, Area 13.50
dec., Kism-Bhith- 1, Boundry, East- Lalan



Singh, West- Road, North- Nageshwar Singh, South- Road, situated at Village & P.O. - Bishunpur Bande, P.S.- Bhagwanpur, District- Vaishali which has been purchased by him on 15.01.2019 for making residential house for his family and started the construction of house as he has no other suitable land for making the house. The Petitioner further prayed that the said proposed Tower No. 35 marked at the west side of the petitioner's land may kindly be sifted at the east side of the said land to save the petitioner's land-house and the lands of many other persons of mango orchard in which they are planning to construct their houses and by which no extra cost is likely to be taken.”
