Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- I) Issuance of Writ in the nature of Mandamus for directing the respondents to grant domestic electric connection to the petitioner.
- II) For directing the respondents to wave the interest on the electric bill raised by the Department which is wrong and illegal in the absence of any electric connection .
- III) For directing the respondents to grant installments for payment of due electric bill and also to act upon the representation filed by the petitioner .



IV) For any other consequential reliefs for which the petitioner is entitled during course of hearing of this writ petition , and in the facts of this case .

Learned counsel for the petitioner states that petitioner is ready and willing to pay the entire outstanding amount in instalment.

The total amount, according to the Revenue, is Rs. 76,000/- and odd.

Let the petitioner pay the same in three equal instalments, spread over a period of three months.

With the deposit of the first instalment, the electric connection be restored.

The instant petition stands disposed of in the aforesaid terms.

Interlocutory Application(s), if any, shall stand disposed of.
