5 22-12-2022 Mr. Rishikesh, learned counsel representing Mr. Abhay Shankar Jha, learned Advocate on Record for the petitioner submits that as per the stand of the B.N. Mandal University (hereinafter referred to as the 'University'), the admitted dues have been paid but there is some discrepancy in the calculation for which liberty may be given to file representation.
