“A. For issuance of a writ in the
nature of CERTIORARI or any other
appropriate writ, order/s, direction/s for

i. Quashing the Tender Notification



dated 04.09.2019 uploaded on the website of Bihar State Food and Civil Supplies Corporation Ltd. and published in the local daily by the Bihar State Food and Civil Supplies Corporation Ltd., West Champaran, Bettiah, seeking selection and empanelment of Transported cum Handling Contractor (Main), and calling upon interested candidates to apply for the same, the last date of submission/uploading of offer/ bid of which has been fixed as 14.11.2019 up to 05.00 P.M. (Annexure-3)

B. For issuance of a writ in the nature of Mandamus, or any other appropriate writ, order/s, direction/s commanding the Respondent Authorities-

(i) To direct the respondent authorities to stay the further processes concerned with the Tender Notification dated 04.09.2019, uploaded and published in the local daily by the Bihar State Food and Civil Supplies Corporation Ltd., Bettiah.

(ii) To direct the Respondent authorities not to take any further step in connection with fresh appointment of Transported cum Handling Contractor (Main), till the expiry of the agreements entered into with the Petitioners and not to intervene in the functioning of the Petitioners which they are discharging in furtherance of the agreements entered into with the Bihar State Food and Civil Supplies Corporation Ltd., Bettiah.

(iii) To show-cause as to on what



grounds the Respondent authorities issued fresh Tender Notification dated 04.09.2019. calling upon interested candidates for appointment of Transported cum Handling Contractor (Main).

C. To grant any other relief reliefs which your lordship may deem fit and proper in the facts and circumstances of the case.”

Learned counsel for the petitioners, under instructions, states that, in view of the intervening developments, the petition may be permitted to be withdrawn.

Prayer allowed.

Petition is disposed of as withdrawn.

Interlocutory application(s), if any, shall also stand disposed of.
